Supply Solutions HumiPro(K) Liquid is a liquid Humic Acid concentrate that is compatible with many liquid fertilizers and micronutrients.

DISPOSITIONS FOR USE

SOIL: Apply 4-10 gallons per acre with fertilizer or with water. Repeated applications may be beneficial.

This product may require agitation when mixed with fertilizer for prolonged periods. For specialized uses, please contact your local Supply Solutions representative.

COMPATIBILITY

HumiPro(K) Liquid is formulated for superior compatibility with liquid fertilizer solutions. When possible, add HumiPro(K) Liquid to tank first, then add fertilizer solution, and mix thoroughly. Always jar test new combinations to reduce risk of incompatibility. When combined with aqua ammonia, vapor releases may result in pressure buildups. For such mixtures, only use mixing and application equipment that are vented and/or have pressure release valves. When mixing with pesticides, dilute Liquid Humic Acid with water prior to the addition of buffering agents and pesticides. DO NOT tank-mix with carbonate based pesticides, as efficacy will decrease. Follow all directions and precautions on pesticide labels prior to mixing with Soluble Humic Acid Solution. Ensure adequate agitation in all situations. DO NOT mix Supply Solutions HumiPro(K) Liquid with calcium nitrate, phosphoric acid, zinc sulfate or other solutions with a pH of less than 6.5
